## Assignment Title: Individual Design Consultant

The Government of India has applied for financing from the World Bank toward the cost of the Uttarakhand Disaster Preparedness and Resilience Project (U-PREPARE), and intends to apply part of the proceeds for consulting services for Individual Design Consultant for Proof checking of the DPRs (Design & Drawings) of proposed bridges under U-PREPARE.

## 2) Short Listing Criteria: -

## 3) Payment terms: -

Payment of the Individual Design Consultant-Bridge will be done on the Deliverable's basis attached in Annexure-3 as per the rates quoted by selected Individual Design Consultant.

## 4) Terms and Conditions: -

#### a) Modification or Variation: -

Any modification or variation of the terms and conditions of this MOU/Agreement, including any modification or variation of the scope of the work or time or cost, may only be made by written agreement between the Parties through amendment/modification. However, each Party shall give due consideration to any proposals for modification or variation made by the other Party.
